# Freja eID Release Notes

---

These Release Notes describe all the changes made to the Freja eID systems from the previous release. They include:

- changes in the Freja eID mobile application from version 2.5.0 (Android) & 2.5.1 (iOS) to 3.0.0

## Summary

- **Freja eID Extended** – Freja eID users in Sweden can now enjoy a middle level of trust – between the Basic and the Plus levels - that grants them greater freedom and flexibility in tailoring their digital identity to their needs. Applying for Extended is quick and completely digital without making any compromises in security.

# Freja eID Extended

Introducing one of the biggest updates to the Freja eID mobile application – Freja eID Extended. **This is a new level available for users, higher than Basic but lower than Plus. Initially the Extended level will only be available for Swedish users.**

Freja eID Extended allows users to further tailor their digital identity to their needs. Previously, users were limited to Basic unless they completed a longer application process to Plus that involved registering their ID document data, taking a photo of themselves and submitting it for security checks. Once (and if) they were eventually approved they still needed to go to one of the stores of our ATG partner to complete the necessary, in-person ID check.

What has changed now is that this process has been broken down so that it is easier for users to reach their desired level of identity assurance at their own pace. The whole journey remains the same, however, once the user has submitted their data for the security check and are approved they are granted the new Extended level, giving them access to more services straight away. It is up to the relying parties to decide, based on regulations and own requirements, which trust level the users need to access their services. In this regard the Extended level also adds greater flexibility on the part of the relying parties. They can for example onboard users on the Extended level and allow certain activities to be carried out on this level and when the need for a higher trust level arises, they can prompt their users to finalize the last step – the physical ID vetting – in order to obtain the Plus level.

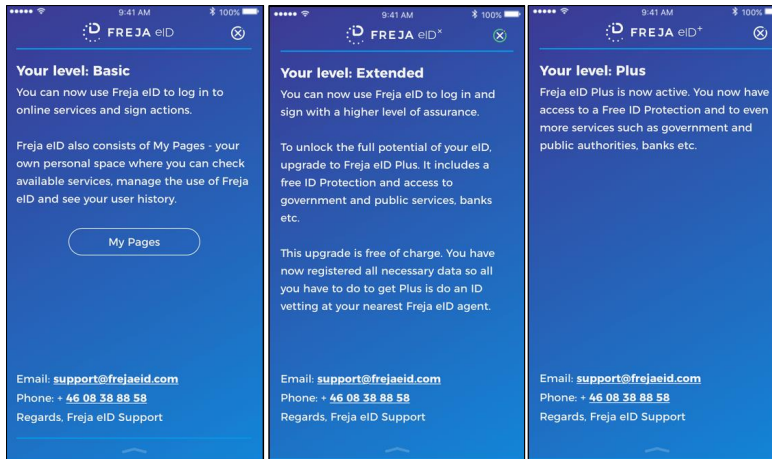
**The entire application process to Extended is digital, applicants need only relax and wait for their digital identity to be approved for a higher level of assurance from the comfort of their homes.**

If they wish to get Plus at some point, all they need to do is complete the ID vetting at ATG. They don't need to submit any new data since we have already verified everything during their upgrade to Extended, provided the document they submitted to get Extended hasn't expired.

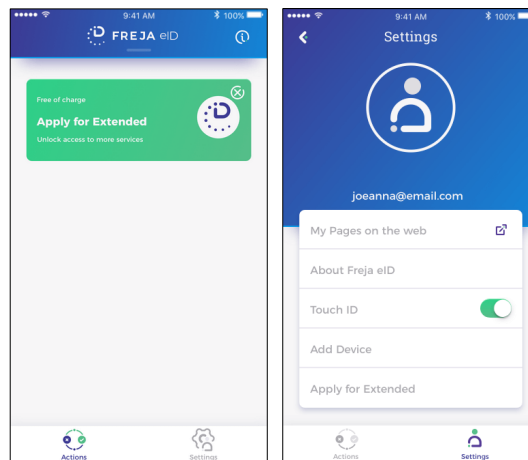
## Procedure

The entire registration and upgrade flow remain intuitive for the user, aided by the drop-down headers whose purpose is to guide users and let them know what is happening with their digital identity at all times.

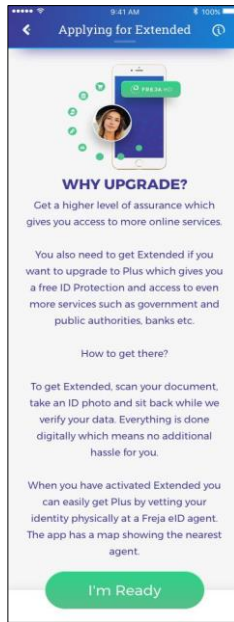
The headers have been reworked to reflect the changes in the Freja eID app but also in terms of additional clarity and precision. They also serve to guide users through the journey from Basic to Extended to Plus.



Once users register to Freja eID Basic they will now have a pending 'Apply for Extended' action in their action list. Alternately, users can always apply for Extended (and Plus) from the Settings menu.

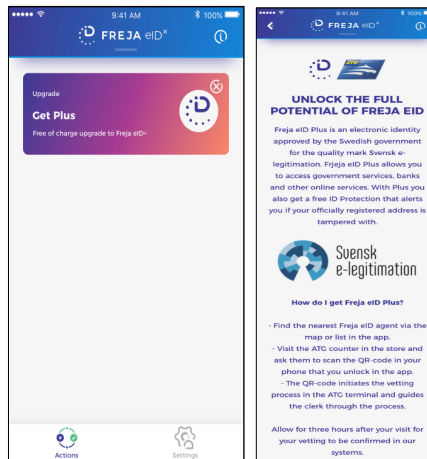


Initiating the application process brings up a screen which gives additional information about Freja eID Extended, why users should apply in the first place and what they get out of it.



Other than that, the process of applying for Extended is the same as when applying for Plus previously. Users need to scan their chosen ID document (or enter data manually), take an ID photo and submit that for security checks.

At the Extended level they will have another pending action. This time it's to get Freja eID Plus and access to even more services, such as a free ID Protection. Tapping on the action will bring up another information screen about Freja eID Plus.



When the user is ready, they just need to perform the in-person security check with their ID document at one of the stores of our ATG partner.
